WHEN: Saturday, November 15, 2014 and Sunday, November 16, 2014

WHERE: Caronport, Barkman Arena

MEET FORMAT and DISTANCES:

- ✚ **Canada Winter Games Skaters** (Age ≥ 14 years on June 30, 2014 and ≤ 19 years on June 30, 2014) will skate on the 111.12m track. They will skate heats and finals 500m, 1000m, 1500m and 3000m. **500m seed time required.**
- ✚ **Neo Senior and Master Skaters** will skate on the 111.12m track. They will skate heats and finals 500m, 1000m, 1500m and 3000m. **500m seed time required.**
- ✚ **T2T skaters** (M12-15, F 11-14) will skate on a 100m track. Skaters will be ranked by ability. Their distances are heat and finals 200m, 400m, 1500m and super final 3000m point's race. **400m seed time required.**
- ✚ **L2T** (M10-12, F 9-11) and **Fundamental** (M6-9, F 6-8) will skate on a 100m track. They will skate heats and finals 200m, 300m, 400m and 1500/1000m. Skaters will be ranked by ability. **300m seed time required.**
- ✚ **Active start** (less than 6 years) will skate a 50m and 100m on the 100m track.
